

BRUNSWICK TOWNSHIP APPROVED MEETING MINUTES

June 14, 2010

The regular meeting of the Brunswick Town Board of Supervisors was held at the Town Hall on Monday, June 14, 2010 at 8:00 p.m. The following were in attendance: Rick Kawalek, Paul Kollar; Craig Peterson; Arlett Mizer; Gladys Nelson; Susan Alderink. The meeting was called to order by Chairman, Rick Kawalek and the flag pledge was said.

M/S/C by Peterson and Kawalek to approve the agenda. M/S/C by Kollar and Peterson to approve the minutes of the May 10, 2010 meeting. The treasurer reported total funds available on May 31, 2010 of \$ 67,468.75. M/S/C by Peterson and Kollar to approve the treasurer report. M/S/C by Peterson and Kawalek to approve the claims.

BUSINESS FROM FLOOR: None

OLD BUSINESS: **Groundhouse River road project:** M/S/C by Kollar and Peterson to have Clerk send letter to D&M Excavating, Inc. They must provide insurance coverage as stated in Paragraph Four of contract for Groundhouse River road project. M/S/C by Kawalek and Kollar that deadline for D&M Excavating, Inc. to comply with Paragraph Four is July 1.

**Mahogany Street:** Grass Lake Supervisors and Brunswick Supervisors, along with Monte of First State Tire, discussed costs to place rubber, and new road bed top and shoulder work on a 2900 foot section of Mahogany Street. Costs to consider were: gravel, fabric and seeding, Consultant Richard Larsen, silt fence and culverts. They discussed the need to do soil borings to determine how much material was available for top of road bed. First State Tire stated they will pay cost to do soil borings and report back at July meetings.

M/S/C by Peterson and Kollar to hire Mark Graber to mow the road ditches at rate of \$ 38.00 per mile (both sides).

NEW BUSINESS: Zoning Administrator issued 4 land use permits – Allan Jacobson; Monte Niemi, Travis Hanson x2. Susan received calls concerning 4-wheeler damage on 130<sup>th</sup> Avenue and the Board asked her to send a letter to all residents on the road expressing our concerns.
