

BRUNSWICK TOWNSHIP APPROVED MEETING MINUTES

April 11, 2011

The regular meeting of the Brunswick Town Board of Supervisors was held at the Town Hall on Monday, April 11, 2011 at 7:00 p.m. The following were in attendance: Rick Kawalek, Jeff Akkerman; Craig Peterson; Shari Hartog; Gladys Nelson; Susan Alderink. The meeting was called to order by Chairman, Rick Kawalek and the flag pledge was said. A sign-in sheet was provided for all in attendance.

M/S/C by Peterson and Kawalek to approve the agenda. M/S/C by Peterson and Akkerman to approve the minutes of the March 14, 2011 meeting. The treasurer reported total funds available on March 31, 2011 of \$ 111,009.03 M/S/C by Peterson and Akkerman to approve the treasurer report. M/S/C by Akkerman and Kawalek to approve the claims (check numbers 5877 – 5893).

BUSINESS FROM FLOOR: Karen Schindeldecker expressed concern about the snowmobile trails in her area – they use the road and are plugging culverts causing culvert to freeze and damage the road. Jeff will take the concern to the Snowmobile Club.

OLD BUSINESS: Road issues – Jeff talked with Greg Nikodym, Kanabec Highway Dept. re: road sign replacements letter received and got clarifications. M/S/C by Akkerman and Peterson to adopt the County Highway Department fees for sign location, database and record keeping.

NEW BUSINESS: Susan reported no Land Use permits but brought and reviewed the permit and the Board approved her suggestions for updates to Land Use and Driveway Culvert permits.



Clerk to relay the decision to Brett Stark at MN DOT in Baxter, MN.

Richard Hass, KCR Construction brought the 2011 equipment and material prices, for Board consideration. M/S/C by Kawalek and Peterson to accept the 2011 KCR Construction prices. Spring road check to be held on Monday, April 18<sup>th</sup> beginning at 4 pm. M/S/ C by Kawalek and Akkerman to allow Gladys Nelson to do 2011 lawn mowing.

M/S/C by Akkerman and Kawalek to approve the 2011 donations as recommended at Annual Town Meeting. (\$400.00 each to Kanabec History Center; Ogilvie First Responders; Seven County Senior Federation; Family Pathways; Mora Fire Department)

The Treasurer brought new signature cards from the Greater MN Credit Union; Board asked Shari to research interest rates and bring info to May meeting for further consideration.
