- M/S/C by Akkerman to pay all bills.



It is the duty of the clerk of township government to appoint a deputy clerk. Ron Peterson has appointed Valerie M. Anderson to be deputy clerk of Brunswick Township for the same term he was elected. Therefore, Gladys Nelson, former clerk and Connie Kawalek, former deputy clerk shall be removed effective immediately from any township status, including any financial access or records. Furthermore, checks on the town depository require three signatures: One of either the Chair or Vice Chair of the Board of Supervisors, one of either the Clerk or Deputy Clerk and one of the Treasurer or Deputy Treasurer. Transfers between accounts may be made by either Treasurer or Deputy Treasurer.
