

BRUNSWICK TOWNSHIP ANNUAL MEETING MINUTES
March 12, 2013

The annual meeting of the electors of Brunswick Township was held in the Town of Brunswick, County of Kanabec, State of Minnesota on the 12th day of March, 2013 at 8:00 p.m. The meeting was called to order by Clerk Peterson: flag pledge was said and Denny McNally was chosen moderator.

A motion by Majal Johnson to approve the agenda was seconded by Rick Kawalek. Motion carried.

The minutes of the 2012 Annual Meeting were read. A motion by Craig Peterson to approve the minutes was seconded by Rick Kawalek. Motion carried.

The Audited Treasurer's report for 2012 contained the following information:

Denny McNally questioned the whether the expense item "Ammonium Sulfate" should be "Ammonium Chloride" and that the category "Building Permits" under revenue should be "Land Use Permits" as the township only issues land use permits. Motion by Connie Kawalek to approve the Audited Treasurer's Report with the exception that "Building Permits" is changed to "Land Use Permits". Seconded by Rick Kawalek. Motion carried.

Clerk Ron Peterson reported that the MPCA order to remove tire shreds in section 6 is being appealed. This appeal is of the October, 2012 removal order by the MPCA commissioner. No information about timing of the appeal is known.

Contribution Requests: Motion by Hazel Miller to provide \$300.00 to each of the 7 organizations present for a total of \$2,100.00. Seconded by Connie Kawalek. Upon polling the representatives it was determined that 8 are present. Motion by Hazel Miller to amend the motion to \$2,400.00. Seconded by Connie Kawalek. Motion to amend carried followed by approval of the main motion to contribute \$300 to the following:


