

BRUNSWICK TOWNSHIP **APPROVED** MEETING MINUTES

May 14, 2012

The regular meeting of the Brunswick Town Board of Supervisors was held at the Town Hall on Monday, May 14, 2012 at 7:00 p.m. The following were in attendance: Jeff Akkerman; Craig Peterson; Rick Kawalek; Shari Hartog; Gladys Nelson; Susan Alderink. The meeting was called to order by Chairman, Rick Kawalek and the flag pledge was said. A sign-in sheet was provided for all in attendance.

M/S/C unanimous by Peterson and Akkerman to approve the agenda. M/S/C unanimous by Kawalek and Peterson to approve the minutes of the April 9, 2012 meeting. The treasurer reported total funds available on April 30, 2012 of \$ 137,176.21. M/S/C unanimous by Peterson and Akkerman to approve the treasurer report. M/S/C unanimous by Akkerman and Peterson to approve the claims (check numbers 6025 – 6037; total of claims \$ 21,269.24).

BUSINESS FROM FLOOR: Grass Lake Township Supervisors Donna Golly and Dan Kent were at the meeting. M/S/C unanimous by Akkerman and Kawalek to approve 2 different sections of road work on Mahogany Street town line. 1) midway through the swamp area build up the shoulder area; install a short piece of culvert into the ends of the old culvert; place rip/rap on the east and west side of road. 2) clean culvert at intersection of Mahogany Street and 120th Avenue; clean west side of road from corner and south so water flows. Grass Lake Supervisors agreed with 2 step plan.

OLD BUSINESS / ROAD ISSUES: Allen Schnack was present and talked about the progress on the Ogilvie Fire Contract. M/S/C by Kawalek and Akkerman to give approval on behalf of Brunswick Township to send an additional letter to Attorney Troy Gilchrist with request for comments on 4 questions. Motion also included the approval of the payment for the additional cost of the letter.

NEW BUSINESS: Zoning Administrator – Susan reported issuance of three land use permits – Kevin Stassen, residence; Earl Bracewell, residence; and Stassen land division. Also reported several calls for junk and/or garbage. Susan responded to these sites and others and requested action as appropriate.

M/S/C unanimous by Akkerman and Peterson to hire Mark Graber to mow the road ditches this summer one time.

M/S/C unanimous by Akkerman and Kawalek to approve 2012 road projects in the following areas: Chloride the one mile stretch on 140th Avenue for second year; approve HP Gravel and Grading to spread up to 5000 yards of gravel; replace culverts and signs as noted in the Spring Road Check notes.

M/S/C by Akkerman and Peterson to adjourn the meeting at 8:45 pm.
